- 5. How to disperse money after the fund is closed: Write check to Marquis family
- 4. Christmas Bonus

 - b. Motion made for the school board to match donation 1:1 up to \$5,000 for staff bonus. Beth seconded the motion. This money will be pulled from general fund.
